KNOW ALL MEN BY THESE PRESENTS:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a government agency with principal office address at IBP Road, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for Social Welfare and Development, **DANILO G. PAMONAG**, (hereinafter called the "PROCURING ENTITY");



CORPORATION (JOINT VENTURE), a corporation organized and existing under Philippine law, with principal business address at 9TH Floor, Philippine Stock Exchange Center, East Tower, Exchange Road, Ortigas Center, Pasig City, Philippines, represented herein by its authorized representative, **JOSEFINO M. PALOMA** (hereinafter called the "SUPPLIER");

WHEREAS, the Procuring Entity through Competitive Bidding invited Bids for certain goods and ancillary services, specifically for the **Supply, Delivery and Installation of Local Network Infrastructure for DSWD Field Offices (ITB No. GOP/20-DSWD-043)** where one (1) prospective bidders submitted their bid proposals, and after deliberation of the Bids and Awards Committee (BAC), has accepted the Bid of the Supplier being the Single Calculated and Responsive Bid (SCRB), with the total contract price **Seventy Million Seven Hundred Ninety-Nine Thousand Nine Hundred Pesos (PhP 70,799,900.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - "G" the Procuring Entity's Notification of Award.
 - "H" the Joint Venture Agreement
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to




provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.






