## KNOW ALL MEN BY THESE PRESENTS:

The DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, a government agency with principal office address at IBP Road, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for Office of the Secretary Group, DANILO G. PAMONAG, (hereinafter called the "PROCURING ENTITY");

INTEGRATED COMPUTER SYSTEMS, INC., a corporation organized and existing under Philippine law, with principal business address at 3F Limketkai Building, Ortigas Avenue, Greenhills, San Juan, Philippines, represented herein by its Authorized Representative, ANNA KARINA FIANGO-OK (hereinafter called the "SUPPLIER");
