## KNOW ALL MEN BY THESE PRESENTS:

**DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a government agency, with principal office address at IBP Road, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for the Office of the Undersecretary of Social Welfare and Development, **DANILO G. PAMONAG**, (hereinafter called the "PROCURING ENTITY")

SANDZ SOLUTIONS PHILIPPINES, INC., a corporation organized and existing under Philippine law, with principal business address at 6/F CYA Land Building, 110 Rada Street, Legaspi Village, Makati City, Philippines, represented herein by its Authorized Representative ALGELINE R. OLILA (hereinafter called "the SUPPLIER");
