For "Improvement/Repair of Existing Policy Development and Planning Bureau Ceiling and Reconditioning of Electrical Wiring and Fixtures"

KNOW ALL MEN BY THESE PRESENTS:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a government agency with principal office address at IBP Road, Batasan Pambansa Complex, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for Policy and Plans, **LUZVIMINDA C. ILAGAN** (hereinafter called the "Entity");

-and-

HGW=3 ENGINEERING & CONSTRUCTION, a sole proprietorship duly organized and under the law of the Philippines, with principal address at Poblacion, Sablan, Benguet represented herein by its Authorized Representative, HILBERT BELA-O WILLIE (hereinafter called the "Contractor");
