KNOW ALL MEN BY THESE PRESENTS:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a government agency with principal office address at IBP Road, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for Social Welfare and Development, **DANILO G. PAMONAG, Office of the Undersecretary for Social Welfare and Development** (hereinafter called the "PROCURING ENTITY");

iONE RESOURCES, INC., a corporation organized and existing under Philippine law, with principal business address at 1006 Centerpoint Building, Julia Vargas Avenue corner Garnet Road, Ortigas Center, Pasig City, Metro Manila, Philippines, represented herein by its authorized representative, **MARIA ELIZA S. AUSTRIA** (hereinafter called the "SUPPLIER");

WHEREAS, the Procuring Entity through Negotiated Procurement – Two Failed Biddings invited Bids for certain goods and ancillary services, specifically for the "Subscription of Managed Electronic Mail (Email) Services with Video Conferencing Solution for DSWD" (DSWD NNP No. 20-TFB-002) where three (3) bidders submitted their bid proposals, and after deliberation of the Bids and Awards Committee (BAC), has accepted the Bid of the Supplier being the Single Calculated and Responsive Quotation (SCRQ), with the total contract price of Twenty Five Million Five Hundred Ninety Five Thousand Three Hundred Seventy Four Pesos and Two Centavos (PhP25,595,374.02) (hereinafter called "the Contract Price").



NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
