CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a government agency with principal office address at IBP Road, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for Social Welfare and Development, **DANILO G. PAMONAG**, (hereinafter called the "PROCURING ENTITY");

-and-

PANTRONICS INTERNATIONAL CORPORATION, a corporation organized and existing under Philippine law, with principal business address at 51-53 General Rosendo Simon Street, Caloocan City, Metro Manila, Philippines, represented herein by its authorized representative, **PILAR O. GONZALES** (hereinafter called the "SUPPLIER");

WHEREAS, the Procuring Entity through Competitive Bidding invited Bids for certain goods and ancillary services, specifically for the Supply and Delivery of Document Scanners for DSWD Central Office where seven (7) prospective bidders submitted their bid proposal, and after deliberation of the Bids and Awards Committee (BAC) and pursuant to BAC Resolution No. 20-07-155 approved on the 22nd of July 2020, has accepted the Bid of the Supplier being the Lowest Calculated and Responsive Bidder (LCRB), with the total contract price of Seven Hundred Fifty Nine Thousand Three Hundred Twenty Five Pesos (PhP 759,325.00) (hereinafter called "the Contract Price"), inclusive of all applicable taxes.
