## KNOW ALL MEN BY THESE PRESENTS:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a government agency with principal office address at IBP Road, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for Operations, **ATTY. AIMEE S. TORREFRANCA-NERI**, (hereinafter called the "PROCURING ENTITY");

HY-INTERNATIONAL UNLIMITED TRADING CO., a corporation organized and existing under Philippine law, with principal business address at 335 Gil Puyat Avenue, Pasay City, Metro Manila, Philippines, represented herein by its Authorized Representative, MICHAEL THOMAS GO (hereinafter called the "SUPPLIER");
