ABSTRACT OF QUOTATIONS NO. 2020-12-0760

WHEREAS, the Department of Social Welfare and Development (DSWD) – Social Marketing Service (SMS) through the DSWD Fund, intends to apply the sum of Two Hundred Ninety-Eight Thousand One Hundred Thirty-Six Pesos and Sixty Centavos (PhP298,136.60), being the Approved Budget for the Contract (ABC) for the Supply and Delivery of DSLR Camera and other accessories. The Purchase Request (PR) No. 01-20001-PR-2020-10-00002 and Technical Assistance Report are hereto attached, marked as Annexes "A", and "B", respectively, and are made integral parts hereof;

WHEREAS, Negotiated Procurement under Small Value Procurement (NP-SVP) was used in this undertaking as indicated in the approved 2020 Annual Procurement Plan (APP) of the Department pursuant to Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 (RA 9184), also known as Government Procurement Reform Act (GPRA);

WHEREAS, the DSWD through the Bids and Awards Committee (BAC), posted a Request For Quotation (RFQ) for the Supply and Delivery of DSLR Camera and other accessories for DSWD-SMS under RFQ No. 20-1189 NP-SV at the Philippine Government Electronic Procurement System (PhilGEPS) and DSWD websites, and at the DSWD premises on 03 December 2020. The RFQ and proof of postings are hereto attached marked as Annexes "C", "D-1", "D-2", and "D-3", respectively, and are made integral parts hereof;

WHEREAS, the Procurement Planning and Management Division (PPMD) of the Procurement Management Service (PMS) conducted canvass by sending the RFQ No. 20-1189 NP-SV to fifteen (15) prospective suppliers. Pursuant to Annex H of the 2016 revised IRR of RA 9184, in NP-SVP, "The BAC shall send the RFQ to at least three (3) suppliers, contractors or consultants of known qualifications. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof." The Proof of Invitation and the Transmittal Memorandum from PPMD are hereto attached, marked as Annexes "E", and "F", respectively, and are made integral parts hereof;

WHEREAS, within the set deadline on 8 December 2020 at 5:00 p.m., three (3) quotations were received by the Bids and Awards Committee Secretariat, as follows:

- 1. 8 Dimensions Trading and Supplies, Inc.;
- 2. Mayer Photo Inc.; and
- 3. K. O. B. S. Customers First Trading, Inc.

The quotations received are hereto attached, marked as **Annexes "G-1"**, **"G-2"** and **"G-3"**, respectively, and are made integral parts hereof;

WHEREAS, the quotations were forwarded to SMS for evaluation. In the evaluation report dated 15 December 2020, the end-user determined that only K. O. B. S. Customers First Trading, Inc. compliant with the technical specifications and responsive to all the documentary requirements. The Request for Evaluation and the Evaluation Report are hereto attached marked as Annexes "H" and "I", respectively, and are made integral parts hereof;



WHEREAS, the result of the evaluation is as follows:

O. B. S. Customers First Trading, Inc., having the Single Calculated and Responsive Quotation. The total contract cost is Two Hundred Eighty-Two Thousand Eight Hundred Eighty-Eight Pesos and Eighty-Eight Centavos (PhP282,888.88), inclusive of all applicable taxes.
