BIDS AND AWARDS COMMITTEE (BAC) Resolution No. 20-04-079

RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF SURGICAL MASK FOR THE NRLMB PERSONNEL, VOLUNTEERS, DONORS, VISITORS, AND WORKFORCE IN NROC (PR NO. 01-20001-PR-2020-03-00258)

WHEREAS, the Department of Social Welfare and Development (DSWD) in its efforts to safeguard the health and safety of the workers providing essential services and ensure that they are provided with immediate support mechanisms, the National Resource and Logistics Management Bureau (NRLMB) requested an emergency procurement of 24,000 pieces of Surgical Mask Disposable under Purchase Request (PR) No. 01-20001-PR-2020-03-00258 as one of the components of the protective equipment to be distributed to the NRLMB personnel, volunteers, donors, visitors and workforce in NROC, with an Approved Budget for the Contract amounting to Six Hundred Seventy-Two Thousand Pesos (PhP672,000.00). Copies of the PR and Project Proposal are hereto attached, marked as Annexes "A", and "B", respectively, and are made integral parts hereof;

WHEREAS, Section 53.2¹ of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA No. 9184) otherwise known as the Government Procurement Reform Act, allows the use of Negotiated Procurement-Emergency Cases whereby the Procuring Entity can directly negotiate a contract with a technically, legally and financially capable supplier. Negotiated Procurement-Emergency Cases may be resorted on the following instances;

- i. In case of imminent danger to life or property during a state of calamity, or
- ii. When time is of the essence arising from natural or man-made calamities or
- iii. Other causes where immediate action is necessary:
 - a) To prevent damage to or loss of life or property, or
 - b) To restore vital public services, infrastructure facilities and other public utilities.

¹ In case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where imminent action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities. In case of Infrastructure Projects, the Procuring Entity has the option to undertake the project through negotiated procurement or by administration or, in high security risk areas, through the AFP.



WHEREAS, the NRLMB, through Director Emmanuel P. Privado, submitted a justification requesting for the emergency procurement of sanitation supplies (70% alcohol, hand sanitizer, germicidal soap, disinfectant concentrate) as well as protective equipment (facemask and gloves). A copy of the Justification is hereto attached, marked as Annex "C", and made an integral part hereof;

WHEREAS, the Civil Service Commission issued a Memorandum Circular (MC) No. 07, s. 2020 (Interim guidelines for Alternative Work Arrangement and Support Mechanism for Workers in the Government for the Duration of the State of Public Health Emergency Pursuant to Proclamation No. 922) dated 11 March 2020, which provides that "the agency head shall ensure that the workers providing essential services such as health workers, first responders, frontline service providers and the likes are provided support mechanisms such as health intervention, stress debriefing, and appropriate technologies to minimize face to face contact." A copy of the MC No. 07, s. 2020 is hereto attached, marked as Annex "D", and made an integral part hereof;

WHEREAS, in the exigency of service and considering the urgency of the aforesaid request and to ensure that competitive prices are obtained, the Procurement Management Service (PMS), through the Procurement Planning and Management Division (PPMD), immediately prepared the Request for Quotation (RFQ) No. 20-0349 NP-Emergency Cases for the 24,000 pieces of Surgical Mask Disposable and sent to the following prospective suppliers, to wit:

- 2. Award of contract to PHIL PHARMAWEALTH, INC. being the technically, legally and financially capable supplier, with a total contract cost amounting to Five Hundred Sixty-Two Thousand Three Hundred Twenty Pesos (PhP562,320.00), inclusive of applicable taxes for the Supply and Delivery of 24,000 pieces Surgical Mask Disposable for the NRLMB personnel, volunteers, donors, visitors and workforce in NROC.
