# BIDS AND AWARDS COMMITTEE (BAC) Resolution No. 20-05-092

RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF STRETCH FILM FOR THE 2<sup>ND</sup> AND 3<sup>RD</sup> WAVE AUGMENTATION OF CORONA VIRUS DISEASE (COVID-19) RELIEF OPERATION (PR NO. 01-20001-PR-2020-04-00094)

WHEREAS, the Department of Social Welfare and Development (DSWD) through the National Resource and Logistics Management Bureau (NRLMB) requested an emergency procurement of 1,300 rolls of Stretch Film under Purchase Request (PR) No. 01-20001-PR-2020-04-00094 to be used for the 2<sup>nd</sup> and 3<sup>rd</sup> wave augmentation of Coronavirus Disease 2019 (Covid-19) Relief Operation with an approved Budget for the Contract amounting to Three Hundred Ninety Thousand Pesos (PhP390,000.00). Copies of the PR and Project Proposal are hereto attached, marked as Annexes "A", and "B" respectively, and are made integral parts hereof;

WHEREAS, Section 53.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA No. 9184) otherwise known as the Government Procurement Reform Act, allows the use of Negotiated Procurement-Emergency Cases whereby the Procuring Entity can directly negotiate a contract with a technically, legally and financially capable supplier. Negotiated Procurement-Emergency Cases may be resorted on the following instances;

- i. In case of imminent danger to life or property during a state of calamity, or
- ii. When time is of the essence arising from natural or man-made calamities or
- iii. Other causes where immediate action is necessary:
  - a) To prevent damage to or loss of life or property, or
  - b) To restore vital public services, infrastructure facilities and other public utilities

WHEREAS, the NRLMB, through Director Emmanuel P. Privado, submitted a justification requesting for the emergency procurement of raw materials, which includes the 1,300 rolls of Stretch Film, to maintain and anticipate the Family Food Packs needed for the augmentation of relief operation to the families affected by the enhanced community quarantine which aims to prevent and mitigate the spread of Covid-19 infection. The emergency procurement request is in pursuant to Republic Act No. 11649 which also known as "Bayanihan to Heal as One Act", an act declaring the existence of a national emergency arising from the Coronavirus Disease 2019 (Covid-19) situation and a national policy in connection therewith, and authorizing the President of the Republic of the Philippines for a limited period and subject to restrictions, to exercise powers necessary and proper to carry out the declared national policy and for other purposes. Copies of the Justification and Republic Act No. 11649 are hereto attached, marked as Annexes "C" and "D" respectively, and are made integral parts hereof;

WHEREAS, in the exigency of service and considering the urgency of the aforesaid request and to ensure that competitive prices are obtained, the Procurement Management Service (PMS), through the Procurement Planning and Management Division (PPMD),



immediately prepared the Request for Quotation (RFQ) No. 20-0398 NP-Emergency Cases for the Supply and Delivery of 1,300 rolls of Stretch Film and sent to the following prospective suppliers, to wit:
