# BIDS AND AWARDS COMMITTEE (BAC) Resolution No. 20-05-094

RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF CANNED TUNA FLAKES FOR THE 2<sup>ND</sup> WAVE, 3<sup>RD</sup> WAVE AND AUGMENTATION FOR COVID-19 RELIEF OPERATIONS (PR NO. 01-20001-PR-2020-04-00089)

WHEREAS, pursuant to the Proclamation No. 922 entitled "Declaring a State of Public Health Emergency throughout the Philippines", all National Government Agencies and Local Government Agencies are enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the spread of the COVID-19. In line with said declaration, the Department of Social Welfare and Development (DSWD) through the National Resource and Logistics Management Bureau (NRLMB) requested an emergency procurement of 440,000 canned Tuna Flakes to be used for the 2<sup>nd</sup> and 3<sup>rd</sup> wave augmentation of Coronavirus Disease (Covid-19) Relief Operation. A copy of the said Proclamation No. 922 is hereto attached, marked as **Annex "A"**, and made an integral part hereof;

WHEREAS, the NRLMB submitted an approved Purchase Request (PR) No. 01-20001-PR-2020-04-00089 for the "Supply and Delivery of 440,000 Canned Tuna Flakes to be used for the 2<sup>nd</sup> and 3<sup>rd</sup> Wave Augmentation of Covid-19 Relief Operation" with an approved Budget for the Contract amounting to Eleven Million Pesos (PhP11,000,000.00). Copies of the PR and Project Proposal are hereto attached, marked as Annexes "B", and "C", respectively, and are made integral parts hereof;

WHEREAS, the NRLMB, through Director Emmanuel P. Privado, submitted a justification requesting for the emergency procurement of raw materials, which includes the 440,000 cans of Canned Tuna Flakes, to cater the anticipated request of the Family Food Packs of the Cities/Municipalities included in the declared Enhanced Community Quarantine. The emergency procurement request is in pursuant to Republic Act No. 11469 which also known as the "Bayanihan to Heal as One Act", "An act declaring the existence of a national emergency arising from the Coronavirus Disease 2019 (Covid-19) situation and a national policy in connection therewith, and authorizing the President of the Republic of the Philippines for a limited period and subject to restrictions, to exercise powers necessary and proper to carry out the declared national policy and for other purposes". Copies of the Justification and Republic Act No. 11469 are hereto attached, marked as Annexes "D" and "E", respectively, and are made integral parts hereof;

WHEREAS, on 6 April 2020, GPPB Resolution No. 06-2020 was issued "Approving the Recommendation to Increase the Allowable Amount of Advance Payment and Issuance of a Circular on the Guidelines for the Emergency Procurement under RA No. 11469. A copy of the said GPPB Resolution No. 06-2020 is hereto attached, marked as Annex "F", and made an integral part hereof;

WHEREAS, Section 3.3¹ of the GPPB Circular 01-2020, "Guidelines for Emergency Procurement under Republic Act No. 11469 or Bayanihan to Heal as One Act", which allows the Procuring Entity to directly negotiate a contract or procure from a legally, technically, and financially capable supplier, distributor, manufacturer, contractor, or consultant. said GPPB Circular 01-2020 is hereto attached, marked as Annex "G", and made an integral part hereof;

WHEREAS, considering the urgency of the aforesaid request and following the market research conducted by NRLMB, the Procurement Management Service (PMS) through Procurement Planning and Management Division (PPMD) immediately prepared Request for Quotation (RFQ) No. 20-0395 Negotiated Procurement-Emergency Cases and was sent to twenty nine (29) suppliers. Copies of the RFQ No. 20-0395 NP-EC together with the proof of invitations and transmittal memorandum from PPMD are hereto attached marked as Annexes "H", "I", and "J" respectively, and are made integral parts hereof;

WHEREAS, Supplemental Bid Bulletin (SBB) No. 1 and 2 were issued announcing extension for the submission of quotation, from 5:00 PM of May 6, 2020 to 12:00 NN of May 7, 2020 and 4:00 PM of May 7, 2020, respectively. Copies of the two SBB are hereto attached, marked as Annexes "K-1" and "K-2", respectively, and are made integral parts hereof;

**WHEREAS,** in response to the RFQ, the following suppliers submitted its price quotations within the specified deadline of submission which was not later than 4:00 p.m. of 7 May 2020, to wit:

- 1. Chistine-Arcy Furniture and Designs, Inc.; and
- 2. Century Pacific Food, Inc.

Copies of the price quotations received are hereto attached, marked as **Annexes "L-1"**, and **"L-2"**, respectively, and are made integral parts hereof;

**WHEREAS**, on 07 May 2020, the BAC Secretariat forwarded the documents to NRLMB for evaluation. The request for evaluation is hereto attached, marked as **Annex "M"** and made an integral part hereof;

**WHEREAS**, on 8 May 2020, NRLMB submitted a narrative report of the result of their evaluation. The summary of the evaluation report is as follows:

Likewise, **NRLMB** was amendable to the delivery of easy open canned tuna flakes and 50 tin cans per boxes "as long as it still complying with the other specifications set by the bureau and total quantity will be delivered in accordance to the approved delivery schedule". NOW, THEREFORE, in view of the foregoing and on the basis of the documents presented, we, the members of the Bids and Awards Committee resolves, as it is hereby resolved, to recommend the following:

1. Use of Negotiated Procurement - Emergency Cases for the "Supply and Delivery of 440,000 cans of Canned Tuna Flakes to be used for the 2<sup>nd</sup> and 3<sup>rd</sup> Wave Augmentation of Coronavirus Disease (Covid-19) Relief Operation", pursuant to GPPB Circular No. 01-2020 on the Guidelines for Emergency Procurement under RA 11469 or the Bayanihan To Heal As One Act; and



2. Award of contract to Century Pacific Food, Inc. being the technically, legally and financially capable supplier, with a total contract cost amounting to Eleven Million Pesos (PhP11,000,000.00), inclusive of all applicable taxes for the "Supply and Delivery of 440,000 cans of Canned Tuna Flakes to be used for the 2<sup>nd</sup> and 3<sup>rd</sup> wave augmentation of Coronavirus Disease (Covid-19) Relief Operation".
