BIDS AND AWARDS COMMITTEE (BAC) Resolution No. 20-05-108

RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF 880,000 CANNED CORNED BEEF FOR THE 2ND AND 3RD WAVE OF AUGMENTATION FOR CORONA VIRUS DISEASE (COVID-19) RELIEF OPERATION (PR Nos. 01-20001-PR-2020-05-00035)

WHEREAS, the Department of Social Welfare and Development (DSWD) through the National Resource and Logistics Management Bureau (NRLMB) requested an emergency procurement of 880,000 Canned Corned Beef under Purchase Request (PR) No. 01-20001-PR-2020-05-00035 to be used for the 2nd and 3rd wave of augmentation for Coronavirus Disease 2019 (Covid-19) Relief Operation with an approved Budget for the Contract amounting to Twenty Two Million Eight Hundred Eighty Thousand Pesos (PhP22,880,000.00). Copies of the PR and Project Proposal are hereto attached, marked as Annexes "A" and "B" respectively, and are made integral parts hereof;

WHEREAS, on 6 April 2020, GPPB Resolution No. 06-2020 was issued "Approving the Recommendation to Increase the Allowable Amount of Advance Payment and Issuance of A Circular on the Guidelines for the Emergency Procurement under Republic Act (RA) No. 11469 or "The Bayanihan to Heal as One Act." A copy of the GPPB Resolution No. 06-2020 is hereto attached, marked as Annex "C", and made an integral part hereof;

WHEREAS, Section 3.3¹ of the GPPB Circular 01-2020 on the Guidelines for Emergency Procurement under Republic Act No. 11469 or the Bayanihan to Heal as One Act allows the Procuring Entity to directly negotiate a contract or procure from a technically, legally and financially capable supplier, distributor, manufacturer, contractor, or consultant. Copies of the GPPB Circular 01-2020 and Republic Act No. 11469 are hereto attached, marked as Annexes "D" and "E" respectively, and are made integral parts hereof;

WHEREAS, the NRLMB, through Director Emmanuel P. Privado, submitted a justification requesting for the emergency procurement of raw materials, which includes the canned corned beef, to maintain and anticipate the Family Food Packs needed for the augmentation of relief operation to the families affected by the enhanced community quarantine which aims to prevent and mitigate the spread of Covid-19 infection. A copy of the Justification is hereto attached, marked as Annex "F", and made an integral part hereof;

WHEREAS, considering the urgency of the aforesaid request the Procurement Management Service (PMS), through the Procurement Planning and Management Division (PPMD), immediately prepared Request for Quotation (RFQ) No. 20 0429 NP-Emergency and sent to the following service providers/suppliers:

- 1. ESPJR Trading;
- 2. DMC Enterprises; and
- 3. Federated Distributors, Inc.

Copies of the RFQ, Proof of Invitation and endorsement Memorandum from PPMD are hereto attached, marked as Annexes "G", "H" and "I", respectively, and are made integral parts hereof;

WHEREAS, the PMS-PPMD exerted all efforts however, only, ESPJR Trading submitted its price quotations within the specified deadline of submission which was not later than 5:00 p.m. of 20 May 2020. A copy of the received **Price Quotation** is hereto attached marked as **Annex "J"**, and made an integral part hereof;

WHEREAS, on 21 May 2020, the BAC through its secretariat forwarded the quotations received to NLRMB for evaluation. A copy of the Request for Evaluation is hereto attached, marked as Annex "K", and made an integral part hereof;

WHEREAS, on 27 May 2020, NLRMB submitted a narrative evaluation report wherein they approved the delivery of Lucky 7 Carne Norte and allowed the delivery in 48 tin cans per box due to urgency of the requirement, as long as they will meet the total quantity required. Furthermore, the NRLMB is also amenable with the supplier's proposed delivery schedule as follows:

Award of contract to ESPJR Trading being the technically, legally and financially capable supplier with a total contract price amounting to Twenty Two Million Eight Hundred Eighty Thousand Pesos (PhP 22,880,000.00), inclusive of all applicable taxes for the Supply and Delivery of 880,000 can of Canned Corned Beef to be used for the 2nd and 3rd wave augmentation of Coronavirus Disease (Covid-19) Relief Operation.
