RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH
EMERGENCY CASES AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY
OF ISOPROPYL ALCOHOL TO BE USED BY NATIONAL RESOURCE AND LOGISTICS
MANAGEMENT BUREAU (NRLMB) PERSONNEL AND VOLUNTEERS NEEDED TO
PREVENT AND MITIGATE THE SPREAD OF COVID-19

(PR. NO. 01-20001-PR-2020-03-00255)

WHEREAS, pursuant to the Proclamation No. 922 entitled "Declaring a State of Public Health Emergency throughout the Philippines", all National Government Agencies and Local Government Units are enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the spread of the COVID-19. In line with said declaration the Department of Social Welfare and Development — National Resource and Logistics Management Bureau (DSWD-NRLMB) requested for the emergency procurement of One Hundred (100) Bottles of 70% Isopropyl Alcohol, Five Hundred (500) Milliliter (ML) to be used by NRLMB personnel and volunteers needed to prevent and mitigate the spread of COVID-19. A copy of the said Proclamation No. 922 is hereto attached, marked as **Annex "A"**, and is made an integral part hereof;

WHEREAS, NRLMB submitted an approved Purchase Request (PR) No. 01-20001-PR-2020-03-00255 for the Supply and Delivery of 100 bottles of Isopropyl Alcohol to be used by NRLMB Personnel And Volunteers needed to prevent and mitigate the spread of COVID-19. The Approved Budget for the Contract (ABC) is Nine Thousand Five Hundred Seventy Pesos (PHP 9,570.00). The Purchase Request (PR) No. 01-20001-PR-2020-03-00255 with complete supporting documents is hereto attached, marked as **Annex "B"**, and is made an integral part hereof:

WHEREAS, the Procurement Planning and Management Division (PPMD) of the Procurement Management Service (PMS) conducted canvass by sending the RFQ No. 20-0341 NP-Emergency Cases to twenty-one (21) prospective suppliers. The Request for Quotation (RFQ) No. 20-0341 NP-Emergency Cases, the proof of invitation and the transmittal memorandum from PPMD are hereto attached, marked as Annexes "C", "D" and "E", respectively, and are made integral parts hereof;

**WHEREAS,** within the set deadline on 03:00 P.M. of 14 April 2020, only (1) quotation was received by the BAC Secretariat. The quotation received is hereto attached, marked as **Annex "F"**, and is made integral parts hereof:

- Award of contract to Christine-Arcy Furniture Designs, Inc., being the technically, legally and financially capable supplier, with a submitted price quotation of PhP95.70/bottle, and with a total contract cost amounting to Nine Thousand Five Hundred Seventy Pesos (PHP 9,570.00), inclusive of applicable taxes.
