## RECOMMENDING AWARD OF CONTRACTS FOR LOT NOS. 2 AND 3 FOR THE SUPPLY, DELIVERY AND INSTALLATION OF OFFICE FURNITURE FOR THE DSWD CENTRAL OFFICE - MALASAKIT BUILDING

WHEREAS, the Administrative Service (AS) – Building and Grounds Management Division (BGMD) of the Department of Social Welfare and Development (DSWD) is in need of a supplier for the Supply, Delivery and Installation of Office Furniture for the DSWD Central Office - Malasakit Building. On 11 September 2020, during the special BAC meeting, the Bid Evaluation Report was carefully reviewed and deliberated and resolved to declare Peniton Trading as "disqualified" for Lot Nos. 1 and 2 for its failure to properly fill-up or indicate the prices in the Price Schedule (For Goods Offered from Within the Philippines) as required under Clause 13.1(a) of Section II. Instruction to Bidders, to verify if LBPI Design International, Inc. if they will accept and will be amenable to bound with the recalculate and corrected bid price of their bid for Lot No. 3 and to proceed with the post-qualification of the Lowest Calculated Bidders for each Lot. Copies of the Bid Evaluation Report and Minutes of the Meeting are hereto attached, marked as Annexes "M" and "N", respectively, and are made integral parts hereof;

WHEREAS, the BAC issued Notice of Disqualification to Peniton Trading and Notice of Bid Evaluation to LBPI Design International, Inc. Copies of said Notices are hereto attached, marked as Annexes "O" and "P", respectively, and are made integral parts hereof;

WHEREAS, for purposes of conducting the Post-Qualification, the BAC requested the following LCBs to submit an additional documents within five (5) calendar days from receipt of notice from the BAC, pursuant to Section 34.2 of the IRR of RA 9184, to wit:

- 2. Design Excellence Home & Office System Co. Lot No. 2

WHEREAS, 15 September 2020, the BAC through its Secretariat received a letter from LBPI Design International, Inc. confirming that they accepted and is amenable to be bound with the recalculate and corrected bid price of their bid for Lot No. 3. A copy of said Letter is hereto attached, marked as **Annex** "R", and made an integral part hereof;

WHEREAS, 16 September 2020, the BAC through its Secretariat received a Motion for Reconsideration from Peniton Trading via electronic mail explaining that the amount was mistakenly placed in the wrong column and apologize for the mistake. WHEREAS, the BAC created a Technical Working Group (TWG), pursuant to Section 12 of the IRR of RA 9184, who will conduct the Post-Qualification of the following Lowest Calculated Bidders for each lot, to wit:

- 2. Design Excellence Home & Office System Co. Lot No. 2
- 3. Progress Home & Office Furnishing / Verde Linear Corp. Lot No. 3

WHEREAS, on 21 September 2020, the BAC in its Special Meeting, carefully reviewed and deliberated the Motion for Reconsideration of Peniton Trading and resolved to deny the request. The BAC issued a response letter to Peniton Trading informing them that their request for reconsideration was denied. WHEREAS, on 7 October 2020, the BAC in its Regular Meeting, carefully reviewed and deliberated the TWG Post-Qualification Report and resolved to refer the TWG findings, for Lot No. 1 in particular, for determination of deviation from the required technical specifications to the End-user, if there is any, for the decision of the BAC. A copy of the Minutes of the Meeting is hereto attached, marked as **Annex** "X", and made an integral part hereof;

WHEREAS, the BAC issued a Memorandum to AS, being the end-user, and refer the findings of the TWG for Lot No. 1 to determine if the offer of CubixOffice, Inc. for Combi Roller Blinds made a deviation from the required technical specifications. A copy of the Memorandum is hereto attached, marked as Annex "Y", and made an integral part hereof;



WHEREAS, on 15 October 2020, the BAC through its Secretariat received a Memorandum from the AS indicating that CubixOffice, Inc. can either offer Aluminum Top Tube or Aluminum Cassette Top Cover and it offered aluminum top tube and not aluminum cassette cover which was acceptable for the end-user. A copy of the Memorandum is hereto attached, marked as Annex "Z", and made an integral part hereof;

WHEREAS, on 16 October 2020, the BAC in its Regular Meeting, carefully reviewed and deliberated the response of the AS for Lot No. 1 and the TWG Post-Qualification Report for Lot No. 2 and 3 and resolved to declare CubixOffice, Inc. as Post-Disqualified and proceed with the post-qualification of the second (2<sup>nd</sup>) LCB for Lot No. 1 and declare Design Excellence Home & Office System, Co. and Progress Home & Office Furnishing/Verde Linear Corp. as the Lowest Calculated and Responsive Bidders for Lot Nos. 2 and 3, respectively. A copy of the Minutes of the Meeting is hereto attached, marked as Annex "AA", and made an integral part hereof;

WHEREAS, the BAC issued Notice of Post-Disqualification to CubixOffice, Inc. for its failure to conform or comply with the required DSWD Specifications in particular to the Combi Roller Window Blinds and Notice of Post-Qualification to IKF Home Furnishing & Office Furniture, being the 2<sup>nd</sup> LCB for Lot No. 1.
