# RECOMMENDING AWARD OF CONTRACT FOR THE HIRING OF INDIVIDUAL CONSULTANT FOR THE DEVELOPMENT OF DATA PRIVACY MANUAL OF THE YAKAP BAYAN PROGRAM INFORMATION SYSTEM

— DSWD RFP No. 21-GOP-SVP-IC-002 — (PR No. 01-20001-PR-2021-02-00139).

WHEREAS, the Department of Social Welfare and Development (DSWD) – Social Technology Bureau (STB) is in need of an Individual Consultant in the Development of Data Privacy Manual of the Yakap Bayan Program Information System with an approved budget for the contract amounting to One Hundred Seventy-Five Thousand Pesos (PhP175,000.00). Copies of the Purchase Request (PR) and approved Terms of Reference (TOR) for the project are hereto attached, marked as Annexes "A" and "B", respectively, and are made integral parts hereof;

WHEREAS, the Consultant shall be selected through Negotiated Procurement under Small Value Procurement pursuant to Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 (RA 9184), also known as Government Procurement Reform Act (GPRA);

WHEREAS, the BAC, commenced on the selection process by posting the Request for Proposal (RFP) at the Philippine Government Electronic Procurement System (PhilGEPS) and DSWD websites, and at conspicuous places within the DSWD premises on 13 April 2021. WHEREAS, pursuant to Section 12 of the 2016 revised IRR of RA 9184, the BAC created a Technical Working Group (TWG) who shall be responsible in evaluating the qualifications of the above-mentioned applicants. A copy of the Memorandum is hereto attached, marked as Annex "I", and made an integral part hereof;

WHEREAS, on 27 April 2021, the TWG submitted an evaluation report to the BAC through its Secretariat, based on the evaluation report Mr. Arquiza got a total score of 25% which is below the 85% passing score while Ms. Cubelo got a total score of 96% and Ms. De Asis- Teodoro garnered a score of 91%, which are higher than the 85% passing score. However, only Ms. Cubelo submitted all the documentary requirements and marked as responsive. A copy of the TWG Narrative Evaluation Report is hereto attached, marked as Annex "J", and made an integral part hereof;

WHEREAS, on 5 May 2021, the BAC carefully reviewed and deliberated the TWG evaluation report and resolved to declare Ms. Cubelo as the Highest Rated and Responsive Applicant/Consultant and to recommend award of contract. A copy of the Minutes of the Meeting is hereto attached, marked as **Annex** "K", and made an integral part hereof;

WHEREAS, the Personnel Administrative Division, pursuant to Administrative Order (AO) No. 03 Series of 2018 an amendment to Memorandum Circular No. 21, series of 2012 as amended by AO No. 08 series of 2016, issued a certification that Ms. Evelyn Cubelo has not been a Permanent/Casual/Contractual Employee or Memorandum of Agreement Worker of the Department of Social Welfare and Development Central Office for the period May 2020 to April 2021. A copy of the Certification is hereto attached, marked as Annex "L", and made an integral part hereof;

NOW, THEREFORE, in view of the foregoing and on the basis of the documents presented, we, the Bids and Awards Committee, resolves as it is hereby resolved to recommend award of contract for the "Hiring of Individual Consultant for the Development of Data Privacy Manual of the Yakap Bayan Program Information



System" under DSWD RFP No. 21-GOP-SVP-IC-002 to Ms. Evelyn L. Cubelo being the Highest Rated and Responsive Applicant (HRRA). The project duration is three (3) months commencing upon receipt of Notice to Proceed. The contract price is One Hundred Seventy-Five Thousand Pesos (PhP175,000.00), inclusive of all applicable taxes.
