RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS PRINTERS FOR DSWD-FMS

WHEREAS, the Finance and Management Service (FMS) of the Department of Social Welfare and Development (DSWD) is in need of a supplier for the procurement of various printers. Copies of the Purchase Request (PR), and Information and Communication Technology Assistance Report are hereto attached, marked as Annexes "A" and "B", respectively, and made integral parts hereof;

WHEREAS, the DSWD through the BAC, posted an Invitation to Bid (ITB) for the Supply and Delivery of Various Printers for DSWD-FMS under ITB No. GOP/21-DSWD-022 at the Philippine Government Electronic Procurement System (PhilGEPS) and DSWD websites, and at conspicuous places within the DSWD premises starting 22 September 2021. The total Approved Budget for the Contract (ABC) is One Million Seven Hundred Twenty-Five Thousand Pesos (PhP1,725,000.00).
