## BIDS AND AWARDS COMMITTEE (BAC) Resolution No. 20-03-042

RECOMMENDING AWARD OF CONTRACT FOR THE SUBSCRIPTION OF A COMPLETE HYPER-CONVERGED INFRASTRUCTURE PLATFORM SOLUTION FOR PANTAWID SYSTEMS, OTHER DSWD SYSTEMS AND SERVICES

— ITB No. GOP/20-DSWD-008 — (PR No. 2019111790)

WHEREAS, programs and projects of the Department of Social Welfare and Development (DSWD) constitutes most of its high profile and important projects that mirrors the current Administrations thrust and priorities plans to achieve the societal goal of improving the well-being of the common citizens. These programs with the help of an Information Systems (IS) directly translate to the delivery of social services that most of the DSWD's clients receives.

Currently, the DSWD's Back End Systems (BES) are composed of 103 servers, 45 storage systems, three (3) data centers and one (1) remote data center. Most of these servers and storage systems are already very old and obsolete (8 years old and older). At the same time, the Department of Budget and Management (DBM) have not given the DSWD Capital Outlay funding for the replacement of these ancient equipment. To move forward, the solution is to subscribe to an Infrastructure as a Service (IAAS) model, which is purely a hardware leasing project which does not compromise the security and data products of the DSWD.

Copies of the Purchase Request (PR), approved Terms of Reference (TOR) and amendments to the TOR per agreements during Pre-Procurement Conference are hereto attached, marked as **Annexes "A-1"**, "**A-2"** and "**A-3"** respectively, and are made integral parts hereof;

WHEREAS, the DSWD, through the Bids and Awards Committee (BAC), posted an Invitation to Bid (ITB) for the Subscription of a Complete Hyper-Converged Infrastructure Platform Solution for Pantawid Systems, Other DSWD Systems and Services under ITB No. GOP/20-DSWD-008 at the Philippine Government Electronic Procurement System (PhilGEPS) starting 24 December 2019. The same ITB was posted at the DSWD website and at conspicuous places within the Department premises on 26 December 2019. The Approved Budget for the Contract (ABC) is Thirty-Seven Million Five Hundred Thousand Pesos (PHP 37,500,000.00). Copies of the said ITB and proof of postings are hereto attached, marked as Annexes "B-1", "B-2", "B-3" and "B-4" respectively, and are made integral parts hereof;

WHEREAS, the Competitive Bidding Procedure for Goods was adopted in this undertaking pursuant to Republic Act No. 9184 (RA 9184) otherwise known as the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, a Pre-Bid Conference was conducted on 03 January 2020 at 10:30 AM and was attended by the following prospective bidders, to wit:

- 1. AG Datacom Phils., Inc.;
- 2. Massive Integrated Tech Solutions, Inc.; and,
- 3. Accent Micro Technologies, Inc.
