BIDS AND AWARDS COMMITTEE (BAC) Resolution No. 20-02-018

RECOMMENDING AWARD OF CONTRACT FOR THE SUBSCRIPTION OF DATABASE MANAGEMENT AND CLUSTER MANAGEMENT SERVICE

— ITB No. GOP/20-DSWD-010 — (PR No. 2019111807)

WHEREAS, the Department of Social Welfare and Development (DSWD) will procure and subscribe to a database management and cluster management service to ensure database clustering and data enterprise backup with highly level of security for a more efficient and effective data management to support all DSWD enterprise needs. Copies of the Purchase Request (PR) and Technical Assistance Report are hereto attached, marked as Annexes "A-1" and "A-2", respectively, and are made integral parts hereof;

WHEREAS, the DSWD, through the Bids and Awards Committee (BAC), posted an Invitation to Bid (ITB) for the Subscription of Database Management and Cluster Management Service under ITB No. GOP/20-DSWD-010 at the Philippine Government Electronic Procurement System (PhilGEPS) on 25 December 2019. The same ITB was posted at DSWD websites and at conspicuous places within the Department premises starting 26 December 2019. The Approved Budget for the Contract (ABC) is Two Million Pesos (PHP 2,000,000.00). Copies of the said ITB and proof of postings are hereto attached, marked as Annexes "B-1", "B-2", "B-3" and "B-4" respectively, and are made integral parts hereof;

WHEREAS, the Competitive Bidding Procedure for Goods was adopted in this undertaking pursuant to Republic Act No. 9184 (RA 9184) otherwise known as the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, a Pre-Bid Conference was conducted on 03 January 2020 at 11:30 AM and was attended by one (1) prospective bidder, Yondu Inc. A copy of the Minutes of the Pre-Bid Conference is hereto attached, marked as Annex "C", and made an integral part hereof;

WHEREAS, the BAC issued a Supplemental/ Bid Bulletin which formed part of the Bidding Documents and was posted at the PhilGEPS and DSWD websites, and at conspicuous places within the DSWD premises, to wit:

WHEREAS, in response to the ITB, one (1) prospective bidder, AG Datacom Phils., Inc., secured a complete set of Bidding Documents upon payment of a non-refundable fee of Two Thousand Five Hundred Pesos (PHP 2,500.00). WHEREAS, on 15 January 2020 at 10:30 AM, during the opening of bids and preliminary examination of the documents submitted by the lone bidder, the BAC had the following findings:

WHEREAS, the BAC, with the assistance of its Secretariat, conducted the Bid Evaluation to determine the Single Calculated Bid (SCB) and if there are computational errors in the bid price submitted by the lone bidder. The Bid Evaluation found AG Datacom Phils., Inc. as SCB, and which yielded the following result:

WHEREAS, the BAC created a TWG pursuant to Section 12 of the 2016 Revised IRR of RA 9184 that will conduct the Post-Qualification of AG Datacom Phils., Inc. A copy of the said creation of TWG is hereto attached, marked as **Annex "J"**, and made an integral part hereof;

WHEREAS, on 06 February 2020, the BAC received the TWG report which found AG Datacom Phils., Inc. as "Responsive" to all the requirements stipulated in the Bidding Documents. A copy of the said TWG report is hereto attached, marked as **Annex** "K", and made an integral part hereof;





WHEREAS, the BAC discussed and deliberated the merits of the TWG report during its Regular Meeting on 13 February 2020. The BAC found that AG Datacom Phils., Inc. is legally, technically and financially capable to provide the goods and services needed by the DSWD, and thus resolved to recommend award of contract to AG Datacom Phils., Inc. A copy of the Minutes of Regular Meeting is hereto attached marked as Annex "L", and made an integral part hereof;

NOW, THEREFORE, in view of the foregoing and on the basis of the documents presented, we, the Bids and Awards Committee, resolves as it is hereby resolved, to recommend award of contract for the Subscription of Database Management and Cluster Management Service under ITB No. GOP/20-DSWD-010 to AG Datacom Phils., Inc., being the Single Calculated and Responsive Bid (SCRB). The Total Contract Price is One Million Nine Hundred Eighty-Eight Thousand Pesos (PHP 1,988,000.00), inclusive of all applicable taxes;
