## RECOMMENDING AWARD OF CONTRACT FOR THE SUBSCRIPTION OF MANAGED SERVICES FOR DSWD COMPLETE SUITE OF PRIMARY ICT SECURITY DEVICES

— ITB No. GOP/20-DSWD-017 — (PR No. 2019121827)

WHEREAS, the Department of Social Welfare and Development (DSWD) has invested greatly in the development and build-up of valuable data and information assets coming from Pantawid Pamilyang Pilipino Program, National Household Targeting Service for Poverty Reduction (NHTSPR), Sustainable Livelihood, Social Pensions, Kapit–Bisig Laban sa Kahirapan–Comprehensive and Integrated Delivery of Social Services (KALAHI–CIDSS, Unconditional Cash Transfer (UCT) and other information systems being used by DSWD. This information and data sets need to be secured and maintained for it to be available and accessible for all of its stakeholders.

In order to ensure business continuity and improved user experience down to the remote operation centers, the Information and Communications Technology Management Service (ICTMS) of the Department recognizes the ever growing threat of hackers, crackers and other internet based risks. With these risks, the project aims to subscribe to comprehensive, expertly managed, and maintained, primary perimeter security devices which will be readily available for DSWD including their pool of expert personnel for managing, maintenance, troubleshooting and repair services.

Copies of the Purchase Request (PR) and approved Terms of Reference (TOR) are hereto attached, marked as **Annexes "A-1"** and **"A-2"** respectively, and are made integral parts hereof;

WHEREAS, the DSWD, through the Bids and Awards Committee (BAC), posted an Invitation to Bid (ITB) for the Subscription of Managed Services for DSWD Complete Suite of Primary ICT Security Devices under ITB No. GOP/20-DSWD-017 at the Philippine Government Electronic Procurement System (PhilGEPS) and DSWD websites, and at conspicuous places within the Department premises starting 27 December 2019. The Approved Budget for the Contract (ABC) is Thirty-Eight Million Pesos (PHP 38,000,000.00). Copies of the said ITB and proof of postings are hereto attached, marked as Annexes "B-1", "B-2", "B-3" and "B-4" respectively, and are made integral parts hereof;

WHEREAS, the Competitive Bidding Procedure for Goods was adopted in this undertaking pursuant to Republic Act No. 9184 (RA 9184) otherwise known as the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, a Pre-Bid Conference was conducted on 03 January 2020 at 03:00 PM and was attended by one (1) prospective bidder, Accent Micro Technologies, Inc. A copy of the Minutes of the Pre-Bid Conference is hereto attached, marked as Annex "C", and made an integral part hereof;

WHEREAS, the BAC issued a Supplemental/ Bid Bulletin which formed part of the Bidding Documents and was posted at the PhilGEPS and DSWD websites, and at conspicuous places within the DSWD premises, to wit:

WHEREAS, the BAC, with the assistance of its Secretariat, conducted the Bid Evaluation to determine the Single Calculated Bid (SCB) and if there are computational errors in the bid price submitted by the lone bidder. The Bid Evaluation found Accent Micro Technologies, Inc. as SCB, and which yielded the following result:

A copy of the Notice of Post-Qualification is hereto attached, marked as Annex "I", and made an integral part hereof;

WHEREAS, the BAC created a TWG pursuant to Section 12 of the 2016 Revised IRR of RA 9184 that will conduct the Post-Qualification of Accent Micro Technologies, Inc. A copy of the said creation of TWG is hereto attached, marked as Annex "J", and made an integral part hereof;

**WHEREAS**, on 05 February 2020, the BAC received the TWG report which found Accent Micro Technologies, Inc. as "Responsive" to all the requirements stipulated in the Bidding Documents. A copy of the said TWG report is hereto attached, marked as **Annex "K"**, and made an integral part hereof;

WHEREAS, the BAC discussed and deliberated the merits of the TWG report during its Regular Meeting on 05 February 2020. The BAC found that Accent Micro Technologies, Inc. is legally, technically and financially capable to provide the goods needed by the DSWD, and thus resolved to award the contract to Accent Micro Technologies, Inc. A copy of the Minutes of Regular Meeting is hereto attached marked as Annex "L", and made an integral part hereof;

NOW, THEREFORE, in view of the foregoing and on the basis of the documents presented, we, the Bids and Awards Committee, resolves as it is hereby resolved, to recommend award of contract for the Subscription of Managed Services for DSWD Complete Suite of Primary ICT Security Devices under ITB No. GOP/20-DSWD-017 to Accent Micro Technologies, Inc., being the Single Calculated and Responsive Bid (SCRB). The Total Contract Price is Thirty-Seven Million Nine Hundred Ninety-Nine Thousand Seven Hundred Twenty-Six Pesos and Sixteen Centavos (PHP 37,999,726.16), inclusive of all applicable taxes;
