Can DSWD issue a Notice of Transfer at least a month before the actual move to the new site address? Site survey usually takes 2 weeks. Service Provider will shoulder 10 TOL only. Installation of TOL is dependent on survey result.	The DSWD, through the ICTMS, will issue a notice of transfer one (1) month in advance. A maximum of 15 transfer sites should be facilitated by the service provider. Valid transfer site requests are those with service installed then transferred to a new location.

Candidates for possible upgrade with a maximum of 15 sites are CO, FO, RDC, NROC, SWADCAP, POOs, SWADs, and Center and Institutions.
	If needed for last mile installation, may we request DSWD to secure the needed permit from respective LGUs?	The DSWD, through the ICTMS, will request permit with LGU if the permit required is within the LGU's premise where the DSWD office is located.
