1.2.14	The Service provider must provide an emergency storage as a service of at least five (5) TB in case it is needed.	Is the emergency storage a cloud-based storage or a physical storage?	DSWD prefers an on-premise physical storage connected to the network, be it SAN or NAS, due to the reason that it is only necessary when there is an abrupt migration or immediate transfer of data.
1.2.15	The Service Provider shall provide service vehicles to DSWD personnel who will be doing on-site activity in the said datacenter.	How many service vehicles are required, and how many DSWD personnel would conduct on-site activities?	The DSWD cannot provide specific number of vehicles as on-site activity is dependent on the availability and accessibility of the services. However, based on experience, at least two (2) persons, but if it requires removal of devices or equipment, at most is four (4) personnel.
4.2.3.	Covering Nine (9) months of paid subscription	If the award will be in June or July then the covered months will become 6 months until December 30 2021, Is it possible to modify the subscription to the standard 12-months subscription with an additional budget based on the additional months? Hauling of servers after a	Budget is available, and DSWD-ICTMS can do a 1-year subscription project, however, this is in the domain of Finance and Management Service (FMS) if they will approve crossing over of the contract from 2021 to 2022.

Hauling Services	Is the transfer of equipment included in the approved budget for the contract?	Yes, the transfer of equipment is included in the ABC.
	Can DSWD provide the specific Brand and Model specifications of the servers/ blade servers to be hauled for hauling with insurance inclusion?	DSWD will only provide the brands and models of the equipment during the onsite inspection to be conducted before the opening of bid.
Site Survey/ Ocular Inspection of the Site	Can the prospective bidders still request for a site survey/ ocular inspection, even after the clarificatory questions have been released by DSWD?	The DSWD, thru the ICTMS can accommodate site surveys/ ocular inspections before the date of submission and receipt of bids. Kindly coordinate with the BAC Secretariat one (1) day before the actual survey.
