1) Valid Certificate of Registration (COR) of their Company with the Bureau of Customs (BOC), (Certified True Copy); and Who shall certify the document?	The Certificate of Registration (COR) will be certified by the Bidder's Authorized Signatory
Where will be the exact location of delivery area, and if unloading equipment is required?	The delivery areas for the DSW warehouse nationwide are already stated in the Price Proposal Form. Kindly refer with the said documents.
	Also, we are not requiring an unloading equipment from the Service Provider as

	what we only require is the provision of enough number of manpower to facilitate the unloading.
Is the container deposit waived?	Nope, since it is refundable; the container deposit will be shouldered by the Service Provider and for their refund once the emptied container has returned to its designated depot.
	Nonetheless, the DSWD, as a consignee of shipment, will just assist in preparing the letter for the refund request address to the shipping line which is payable to the Service Provider's company name with the attached Official Receipt as proof of payment and transaction.
Is information on free time detention/demurrage available?	Yes, it is available but it will depend on the shipping line's internal regulations and in average; majority of the shipping lines allotted a seven (7) days free-time period from the date of shipment's arrival.
What is the timing of availability of documents for DOF submission? This is for duty exemption.	Please be informed that we are submitting and processing the request for Duty and Tax Exemption to the DOF prior to the arrival of shipment as we require our shipper/ donor to submit, in advance, the pertinent shipping documents required to expedite the said request.

II. Deadline for the Submission and Receipt of Bids

The schedule for the deadline for the submission and receipt of bids is moved from 17 March 2021 to **24 March 2021** at **09:00 AM.** Bids must be delivered to the BAC Secretariat Office, 2nd Floor, Mahusay Building, DSWD Central Office. **Late Bids will not be accepted.**

The Bid Opening will immediately follow after the deadline of submission and receipt of bids, to be held at the PMS Conference Room, 2nd Floor, Mahusay Building, DSWD Central Office, IBP Road, Constitution Hills, Quezon City.
