### III. Queries from Prospective Bidders

#### Question:

1. On Pages 68 and 70 of the Bidding Documents, under Project Scope, it stated that "1.1.1.2.4. Single Sign-On Integration" and 1.1.2.2.4. Single Sign-On Integration" respectively, what is the required brand and version?

#### Response:

Single Sign-on Integration is a part of the specification of the email therefore it would not require any brand or version. It only means that Google applications (e.g. Google Mail, Google Drive, Google Hangouts, etc.) share a common authentication. When the user logged in to Google Mail, the user simultaneously logged in to all other G Suite apps.

#### Question:

2. On Page 37 of the Bidding Documents, under ITB Clause 5.4 (Single Largest Completed Contract), can a bidder submit a project using Microsoft O365 as SLCC while its ongoing and competed track record are Google-based?

#### Response:

Yes, a project using Microsoft O365 as SLCC is acceptable.

#### Question:

- 3. On Page 40 of the Bidding Documents, under ITB Clause 29.2 (Post Qualification), particularly on the PhilGEPS Certificate of Registration (Platinum Membership):
  - a. is a bidder not required to submit a Platinum Certificate from PhilGEPS?
  - b. if a bidder do not have Platinum Certificate, can the bidder still submit its bid?
  - c. if a bidder's PhilGEPS Platinum Certificate is still in process, can the bidder still submit its bid and what documents will be required in lieu of Platinum Certificate?
  - d. can the bidder submit the PhilGEPS Platinum Certificate during Post Qualification?
