I. Clarifications

This is to reiterate that the project was intended for the year 2020 to 2022 and the estimated quantity is for the year 2020 to 2022. The Price Proposal Form will determine the lowest calculated bidder.

As stated in "Section VI. Schedule of Requirements" under "II. Estimated Quantity and unit Cost per year and Area of Deliverables", the Estimated Unit Cost will be the maximum price per unit the bidder may bid and will be the basis of the actual billing during contract implementation.

This is to reiterate also the Mayor's Permit/Business Permit that expired on December 31, 2020, submit a valid Mayor's Permit/Business Permit (2021) or a copy of Official Receipt of the renewal and the expired 2020 Mayor's Permit/Business Permit.

II. Deadline for the Submission and Receipt of Bids

The schedule for the deadline for the submission and receipt of bids is moved from 13 January 2021 to 20 January 2021 at 09:00 AM. Bids must be delivered to the BAC Secretariat Office, 2nd Floor, Mahusay Building, DSWD Central Office. Late Bids will not be accepted.

The Bid Opening will immediately follow after the deadline of submission and receipt of bids, to be held at the Agency Operation Center, Ground Floor, Mahusay Building, DSWD Central Office, IBP Road, Constitution Hills, Quezon City.

III. Issuance of Bidding Documents

The issuance of bidding documents is extended until 20 January 2021 at 08:00 AM.
