If so, can we use only one form for this? Since the form doesn't show which to use for Lot 1 & Lot 2.	Yes, the bidder can use one (1) project as SLCC for both lots as long as the awarded contract price for that project is equal to at least fifty percent (50%) of the ABC of each lot and is similar to the project to be bid.
Bid Form	Can the bidder submit two (2) separate bid form for each lot?	The bidder may submit one (1) financial bid form provided the lot or lots in which the bidder wishes to participate is/are indicated in the bid form OR two (2) separate bid form for each lot.
