I. This Supplemental/ Bid Bulletin is issued to all prospective bidders announcing amendments in the submission of documentary requirements. The said Supplemental/ Bid Bulletin is in accordance with Section 6 of the GPPB Resolution No. 09-2020 dated 7 May 2020 "Approving Measures for the Efficient Conduct of Procurement Activities during a State of Calamity, or Implementation of Community Quarantine or Similar Restrictions, which provides that:

"In consideration of the limited access to financial institutions, regulatory and other offices, as well as the implementation of government restrictions on transport and travel, <u>ALLOW PEs to accept the following alternate documentary requirements for procurement activities during a State of Calamity, or implementation of community quarantine or similar restrictions</u> and declared or being implemented either in the locality of the PE or the Bidder:

- 6.1 Unnotarized Bid Securing Declaration:
- 6.2 <u>Expired Business or Mayor's permit with Official Receipt of renewal application</u>, subject to submission of Business or Mayor's permit after award of contract but before payment;
- 6.3 <u>Unnotarized Omnibus Sworn Statement</u> subject to compliance therewith after award of contract but before payment; and
- 6.4 Performance Securing Declaration (PSD) in lieu of a performance security to guarantee the winning bidder's faithful performance of obligation under the contract, subject to the following:
 - a. Xxx...:
 - b. An Unnotarized PSD may be accepted, subject to submission of a notarized PSD before payment, unless the same is replaced with a performance security in the prescribed form, Xxx...;
 - c. The end-user may require the winning bidder to replace the submitted PSD with a performance security in any of the prescribed forms under Section 39.2 of the 2016 revised IRR of RA No. 9184 upon lifting of the State of Calamity, or community quarantine or similar restrictions, as the case may be."
