I. Technical Specification

a. Section 1.2 under Qualification of Service Provider

b. Question: The chemical dusting as stated under *No. 2 of B. Spot Termiticide Application under Technical Specification* is already banned by the FDA. What will be the alternative technology?

Answer: For prevention of termite infestation, an applicable termite baiting system shall be installed in the buildings and injection of termiticide solution shall be done on infested areas.

c. Question: Is Soil Poisoning and Baiting System be used simultaneously as stated under Section 2.1 (A) and under B. Spot Termiticide Application under the Technical Specification, respectively?

Answer: Yes, to create a fortified barrier against termite infestation, soil poisoning and installation of an applicable baiting system shall be done/installed

on the perimeter of the buildings.

d. Site Inspection

Site inspection shall be required and shall form part of the post-qualification requirement.

Through a separate memo, the AS, through the BAC Secretariat, shall inform the bidders on the schedule and procedure of site inspection.
