This Supplemental/Bid Bulletin is issued announcing response to the query of the prospective bidder, as follows:

I. Queries/clarifications of the Prospective Bidders

Question: What if the offered thickness of the tin cans is 0.17mm, is it possible to consider no beads since the tin can is thicker, because according to our supplier some of the tin can they use has no beads because the thickness is enough for not easily deforming the item?

Answer: The tin cans should have a minimum of 10 beads per can to provide additional strength and stability to the body.

Question: If the end-user has a preferred brand for the cans?

Answer: There is no preferred brand for the cans. The prospective bidders must ensure that the offered cans will meet the technical requirements set by the department.

Question: About the Schedule Requirement, if the lead time for 1st Tranche is 15 days from NTP, and the 2nd Tranche is 28 days, it means from between 15 days to 28 days is 13 days of delivery period or from the 1st Tranche Plus 28 days of delivery?

Answer: The lead time for the delivery are as follows:

- 1st Tranche 15 calendar days from the receipt of Notice to Proceed (NTP); and
- 2. 2nd Tranche 13 calendar days from the 1st delivery schedule (28 calendar days from the receipt of NTP).

II. Deadline for the Submission and Receipt of Bids

The deadline for the submission and receipt of bids is on 25 August 2021, 09:00 a.m. Bids must be delivered to the Procurement Management Service, BAC Secretariat Office, 2nd Floor, Mahusay Building, DSWD Central Office, IBP Road, Constitution Hills, Quezon City.
