The Department of Social Welfare and Development (DSWD), through the Pantawid Pamilya Capital Outlay Funds, intends to apply the sum of Five Million Five Hundred Thousand Pesos (PhP 5,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply, Delivery and Installation of One Rack Server Solution. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The DSWD will hold a **Pre-Bid Conference** on **22 December 2014** at **04:00 p.m.**, at the **Directors Dormitory** (**Executive Lounge**), **DSWD Central Office**, **IBP Road**, **Constitution Hills**, **Quezon City** which shall be open only to all interested parties who have purchased the Bidding Documents.
- 6. Bids must be delivered to the address below on or before **11:00 a.m.** of **07 January 2014**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **07 January 2014**, **11:00 a.m.**, at the **Directors Dormitory** (Executive Lounge), **DSWD Central Office**, **IBP Road**, **Constitution Hills**, **Quezon City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.
