"ENGAGEMENT OF AN INTEGRATED COMMUNICATION AGENCY FOR THE IMPLEMENTATION OF A COMMUNICATION FOR DEVELOPMENT (C4D) AND DIGITAL MEDIA TRAINING"

- 1. The Republic of the Philippines, through the Social Marketing Service (SMS) General Administration and Support Services (GASS) Funds, of the Department of Social Welfare and Development (DSWD), intends to apply the sum of Two Hundred Eighty Thousand Pesos (PhP280,000.00) being the Approved Budget for the Contract (ABC) as payment for the "Engagement of an Integrated Communication Agency for the Implementation of a Communication for Development (C4D) and Digital Media Training".
- 2. The project aims to engage a reputable integrated communication agency who shall take the lead in implementing a Communication for Development (C4D) and Digital Media Training workshop that will elevate the knowledge and improve the capacity of DSWD's information officers from the central and regional offices to implement communication activities and manage different social media platforms.

3. Scope of Work are as follows:

After conducting consultations, review of necessary documents, the integrated communication agency shall work jointly with the Social Marketing Service (SMS) Director, key project staff, and other consultants in carrying out the following tasks:

- a. Prepare the design for 3-day communication for development (C4D) and digital media training;
- b. Conduct and facilitate the three-day training based on the agreed or approved design and methodology;
- c. Prepare and submit a documentation of the workshop; and
- d. Prepare and submit an integrated communication plan based on the workshop outputs.

4. Degree of Expertise, Qualification, and Competencies:

The Integrated Communication Agency should possess an extensive experience in undertaking the required services as detailed in the scope of work and with the following qualifications, to wit:

- a. Establish organization duly recognized by the Securities and Exchange Commission (SEC);
- b. Has a dedicated Advocacy Communication Unit that will design and implement the workshop;



- c. Experience in working with the government and/ or non-government organizations;
- d. Implemented at least three (3) workshops with similar topics; and
- e. Subject-matter experts with relevant professional background in journalism, development work, and digital marketing.
- 5. In consideration with the consulting services required, payment of the consultant/ service provider shall be made in accordance with the following schedule:

The Department shall pay the communication agency/service provider of the Total Contract Price (TCP) is inclusive of all applicable taxes (withholding tax), professional fees and transportation costs of facilitators, documenters, and resource persons and other out-of-pocket expenses, e.g. workshop materials, and other logistical costs.

Full payment shall only be made upon the completion of the workshop, submission of narrative documentation report, and terminal report with communication plan and corresponding recommendations.

6. This project shall be procured using Section 53.9 (Negotiated Procurement-Small Value Procurement) of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 or the Government Procurement Reform Act and pursuant to the following criteria:

 - viii) Comprehensive Curriculum Vitae (CV) of the team members; and
 - ix) Technical Proposal (Proposed Methodology and Approach).



The Consulting Firm shall be required to issue Official Receipt (OR) as acceptable evidence of receipt of payment for disbursements.
