### SWORN MANIFESTO and OATH OF HONESTY

Should I fail in my commitments under this Oath, I shall bear the pain of the consequences thereof within the limits of all applicable laws of the Republic of the Philippines. May the Almighty assist me in the faithful fulfillment of my oath.
