This pertains to your Memorandum¹ requesting the Legal Service (LS) to review the attached draft Special Order² authorizing the Assistant Secretary and Head of PBRMO to do the following acts:

- 1. To facilitate the timely onboarding and integration of the Application Programming Interfaces (APIs) of these partners into the DSWD Kaagapay Portal:
- 2. To sign all necessary enrollment forms, applications, and other documentary requirements needed for the integration, ensuring the smooth and efficient incorporation of these partners into the Kaagapay Portal; and
- 3. To enable the timely processing of all necessary documents, thereby accelerating the integration of Electronic Money Issuers (EMIs) and logistics partners.

This authorization is intended to support the ongoing development of the DSWD Kaagapay Portal which is designed to streamline the donation process for disaster relief, DSWD centers, residential care facilities, and other beneficiaries. Given the urgent need to expedite the integration of various Electronic Money Issuers (EMIs) and logistics partners into the system, this authorization is being requested by PBRMO.

In this regard, please consider our comments below.

Pursuant to Section 7, Chapter 2, Book IV of Executive Order No. 292 or the "Administrative Code of 1987", the Department Secretary is authorized to delegate authority to officers and employees of the Department of Social Welfare and Development (DSWD) under his direction and supervision. Consequently, it is within

the Secretary's discretion to authorize the Head of the PBRMO and the Assistant Secretary to undertake the actions specified herein.
